

#### Overview

This is an examiner position. You can download the manual and the portfolio from the CSPA Website (<u>www.cspa.ca</u>). Your portfolio is used to record work on the tasks your own pace over a maximum period of one (1) year. When you are done, submit your portfolio to CSPA (<u>office@cspa.ca</u> or 613-916-6008). Once you have received your updated affiliation card with the Certified SSE Rating, you become a Skydiving School Examiner.

#### Prerequisites\*

- C CoP
- SSI Certified
- GCI Certified
- either JM Certified or PFFI Certified or C2 Certified

\* All prerequisite ratings must be Certified and current when applying for SSE Rating.

#### **SSE Manual**

The SSE Manual contains the following information: EJR, Night jump, Water jump, Course Evaluator Information, CoP application forms as well as a section on the CoP process and procedures. This manual can be downloaded from the CSPA website.

#### Training Process & Portfolio Task List

Candidates obtain portfolios from the CSPA website and then work on completing the portfolio tasks. Upon completion, send the portfolio to the office for certification. A one (1) year period is allowed to complete all tasks.

#### Portfolio Task List (Under Direct Supervision)

- 1. Write the A, B & C CoP exams, open book. Correct the exams with a Certified SSE to 100%.
- 2. Understand the source references for CoP exam questions.
- 3. Administer two CoP exams.
  - a. Understand the process: Preparation, Supervision, Exam correction, Debrief and Documentation.
  - b. Include the name of person taking exam, date, score and supervising person.
- 4. Receive the Night & Water Endorsements by the supervising instructor and get instruction on how to administer the Night & Water Endorsement briefings.
- 5. Receive Emergency Procedures Review (EPR) endorsement briefing/info from the supervising instructor.

#### Privileges

- May act as an examiner for CoPs. (Note: may only administer D CoP if you have a D)
- May act as the Chief Instructor for a CSPA Member
- Administer EJR Exam (note: only if you are EJR certified)
- Administer and sign off Night Endorsement
- Administer and sign off Water Endorsement
- Administer and sign off Emergency Procedures Reviews for Solo, A, B & C CoPs
- Qualify for the Learning Facilitator Training Seminar (upon reaching 1,000 jumps, D CoP and C2 Certified)

#### **Certification:**

- 1. The practical component for SSE requires that you complete ALL of the tasks in this portfolio under the direct supervision of a certified SSE within a 12 month period. Have your portfolio signed by a certified SSE when completed.
- 2. Your C1, SSI, GCI, and either JM, PFFI or C2 must all be certified and appear on your affiliation card.
- 3. You can start the SSE portfolio while you complete a prerequisite. However, all prerequisites must be certified at the time of SSE portfolio submission.

Once you have completed the above requirements, please do the following:

#### 1. Maintain a copy of the Portfolio for your own personal records

2. Email a scanned copy of the portfolio to <u>office@cspa.ca</u>. The scanned copy must be legible and "full" sized (not reduced).

Once this is done and approved, a new affiliation card will be sent to you and you will be a Certified Skydiving School Examiner with the CSPA. You will have to renew your CSPA affiliation and your rating according to the currency requirements outlined by CSPA.

#### **Revalidation Up To 5 Years**

- Administer 1 CoP, ratings portfolio, or revalidation form under the direct supervision of a Certified SSE
- Complete the Revalidation Form
- Submit the Revalidation form to office@cspa.ca

#### **Revalidation After 5 Years**

- Obtain an SSE briefing from a Certified SSE
- Complete a full SSE Portfolio issued by Certified SSE.
- Submit the completed portfolio to office@cspa.ca
